

# FITTING INSTRUCTIONS FOR ECS0078BK ENGINE CASE SLIDERS HONDA CB 500 F 2013- (LEFT HAND SIDE ONLY)



Please note that the way the kit is packed does not necessarily represent the way of mounting to the bike

You will need 8mm socket and a 4mm Allen key and torque wrench to complete the fitment of this product

## Left-hand side (as you sit on bike)

- Remove three M6 bolts as arrowed above.
- Insert new button head screws with washers through slider.
- Offer up to bike.
- Tighten evenly to manufactures specified torque.
- Fit bubble sticker as shown above.

## LA FAÇON DONT LE KIT EST EMBALLE NE CORRESPOND PAS FORCEMENT A LA FAÇON DE MONTER LES PIECES SUR LA MOTO.

Vous aurez besoin d'une clé de 8mm et clé Allen de 4mm, ainsi qu'une clé dynamométrique pour l'installation de ce produit.

#### Coté gauche (assis sur la moto)

- Enlever les 3 boulons M6 comme fléchés ci dessus.
- Insérer les nouvelles vis à tête en capuchon avec les rondelles à travers les sliders
- Monter l'ensemble sur la moto.
- Serrer de façon égale aux couples spécifiques d'usine.
- Mettre les stickers en gomme R&G.
